and Municipal Courts and the Dona Ana County Detention Center for jail diversion services.

FIC-DAC assists the courts in Dona Ana County by providing a service to obtain Treatment Guardians. FIC-DAC recruits community members and trains them to become treatment guardians. These treatment guardians are responsible for the health and treatment issues of a mentally ill individual.
