

**DOÑA ANA COUNTY RESOLUTION NO. 2013-39**

**RESOLUTION SUSPENDING APPLICATION AND APPROVAL PROCESS FOR ACCEPTANCE OF PRIVATE ROADS FOR COUNTY MAINTENANCE UNDER RESOLUTION NO. 2005-22**

**WHEREAS**, the Board has previously established under Resolution No. 2005-22 (codified as DACC §279-153, *et seq.*) an application and approval process for acceptance of maintenance responsibility for private roads not meeting County road standards; and

**WHEREAS**, due to budgetary limitations and the historical expense associated with acceptance of maintenance responsibility for private roads not meeting County road standards, the Board finds it necessary to suspend the application and approval process as to such roads until further determination of the Board.

**NOW, THEREFORE, IT IS RESOLVED** that the Board of County Commissioners hereby suspends the application and approval process for acceptance of maintenance responsibility for private roads not meeting County road standards, established under Resolution No. 2005-22 and codified as DACC §279-153, *et seq.* No new applications for such roads under Resolution No. 2005-22 shall be considered by the Board until the Board, by Resolution, decides to reinstate the application and approval process based on additional selection criteria, maintenance requirements, and financial considerations. The following existing private road maintenance applications shall continue to be processed by the County: Corona, McCrimon, Ward, Twilight, Rusbayo, and Singh.


